

copy of the same has to be forwarded to the Revocation Applicant. No time extension will be granted to the parties for filing of evidence. Time limit has to be adhered strictly by the parties as mutually agreed and if the same is not filed on the said date the matter will proceed for final hearing.

The final hearing in this matter will be fixed later depending on the magnitude of the evidence filed and the date of final hearing will be informed to the parties separately.
