## Monitoring of DUS Test

- DUS Monitoring of sorghum trials was conducted on 1-2 October, 2013 by a team under the Chairmanship of Dr. R.C Sharma, Former



Dean, College of Horticulture, University of Horticulture & Forestry, Nauni, Solan along with Dr. Aruna C, Principal Scientist (Plant Breeding), Dr. Hariprasanna K, Senior Scientist (Plant Breeding) visited the *Kharif* trials at Directorate of Sorghum Research, Rajendranagar, Hyderabad. The Project Coordinator Dr. S.S. Rao, Director I/C, DSR, Hyderabad was also present. Representatives from private seed companies viz., Kaveri Seeds and Nuziveedu Seeds also attended the monitoring.

- Dr. Tejbir Singh, Registrar, PPV&FR Authority has visited at MPKV, Rahuri for Monitoring of sorghum crop on 3 October, 2013 and pearl millet on 4 October, 2013. The monitoring was conducted under the Chairmanship of Dr. P.A. Nawale.



- DUS Monitoring of rice was conducted at DRR, Hyderabad during 29-30 October, 2013. Dr. S.R. Dhua, Chairman, Monitoring team, former Principal Scientist, CRRI, Cuttack. Shri D.R. Choudhury, Joint Registrar, PPV&FR Authority.



- The DUS monitoring of brinjal trials was conducted on 30 December, 2013 under the Chairmanship of Dr. A. N. **Training cum Awareness program** at CAZRI



Regional Research Station, Bhuj (Kachchh). Central Arid Zone Research Institute (CAZRI) organized one-day awareness-cum-training programme on “Protection of Plant Varieties & Farmers’ Rights” at Regional Research Station (RRS), Kukma, Bhuj (Gujarat) on 13 December, 2013. Dr. R.R. Hanchinal, Chairperson, Protection of Plant



Varieties & Farmers’ Rights (PPV&FR) Authority, New Delhi active participation and told them about various awards of the Authority to be conferred to the farmers and specially requested the women farmers to come forward for protecting the plant varieties wealth of the region. He has also released a brochure in Gujarati on Protection of Plant Varieties & Farmers’ Rights Act. Sh. Trikam Bhai Chhanga, Pramukh, Zila Panchayat, Bhuj as the Chief Guest briefed about the horticulture sector improvement in Kachchh and assured that the farmers of this area will definitely be benefitted with the protection of their plant varieties and rights. Dr. M. M. Roy, Director, CAZRI highlighted about the CAZRI’s involvement and commitment in the

proper implementation of this Act in the region, research projects executions in this aspect and future perspective. Dr. Devi Dayal, Head, CAZRI, RRS, Bhuj and Dr. R.K. Bhatt, Principal Scientist & Principal Investigator, CAZRI, Jodhpur also addressed the gathering. Dr. Devi Dayal, Head, CAZRI, RRS, Kukma narrated about the local plant varieties available only in Kachchh region such as Wheat - Tukda/Kantha, Groundnut - Magadi, Sorghum - Gundari, Pearl Millet - Rajka Bajri, Guar - Desi Guar (pink colour), and medicinal plants (Guggal, Geloy, and Shankhpushpi), etc., which are still not registered. About 150 participants comprising 25 women farmers and other stakeholders participated in this training programme.

- **Training-cum-Awareness program at UAS, Bangalore:** A one day training-cum-awareness programme on PPV & FR Act, 2001 organised at GKVK, Bangalore on 21 December, 2013 at



GKVK, Bangalore. More than 200 participants viz Scientists of Plant Genetic & Resources Department, Biotechnology Department, Students, Researchers and progressive farmers participated in the programme. Dr. R. R. Hanchinal, Chairperson, PPV & FR Authority was invited as Chief Guest and Hon’ble Vice-Chancellor, Director of Extension and Director of Research of GKVK, Bangalore also graced the occasion. highlighted the importance of the registration of farmers varieties and legal provision under PPV & FR Act, 2001. An exhibition was also showcased by the Authority where seeds of farmers' varieties were displayed and posters and charts and other literature was shown. The Nukkad Natak and documentary on agro-diversity were also screened for benefits of the participants.

- **Awareness program at KVK Hulkoti on 14 & 28 December, 2013** K.H. Patil Krishi Vigyan Kendra, Hulkoti in Gadag district of Karnataka organized Awareness cum training programme on the provisions of Protection of Plant Varieties



& Farmers' Rights Act, 2001 for stakeholders including farmers on 28 December, 2013. The event was inaugurated by Dr. R.R. Hanchinal, Chairperson, Protection of Plant Varieties and Farmers Rights Authority, New Delhi. He called upon the farmers to register the traditional seed varieties and avail the benefits of PPV & FR Act, 2001. He informed that the traditional seed varieties can be used to develop new varieties which can bring food and nutritional security to the people.

Shri C.B. Balaraddi, Joint Director of

Agriculture, Karnataka State Department of Agriculture among the farming community. Shri C.R. Budihal, President of Chenna Veereshwar, Seed Bank participated as the Guest and urged the State Government to initiate the measures to take up seed production programme of traditional seed varieties

The programme was presided by Shri Raju C. Koravanavar, Director of Dharitri, an organization involved in promotion of traditional seed varieties. Dr. L.G. Hiregoudar, Programme Coordinator spoke on objectives of organizing the programme. After the inaugural programme, orientation program to the farmers on provisions of Protection of Plant Varieties and Farmers' Rights Act, 2001 was organized. Resource material in Kannada language on the activities of PPV & FR Authority was supplied to farmers. On this occasion an Exhibition of traditional seed varieties conserved by the farmers was also arranged and it was inaugurated by Dr. R.R. Hanchinal, Chairperson, PPV & FR Authority, New Delhi. KVK felicitated 13 farmers of Gadag district who were involved in production and conservation of traditional seed varieties. The applications of these farmers for registration of their varieties have been already submitted to PPV & FR Authority.

The traditional seed varieties of crops viz; jowar, wheat, maize, green gram, Bengal gram, cowpea, pea, black gram, groundnut, brinjal etc., were exhibited

- **MPKV, Rahuri:** A one day training-cum-awareness programme was organised at Rahuri on 19 October, 2013 where Hon'ble Chairperson of the Authority was the Chief Guest. On this Occasion Vice-Chancellor, MPKV along with his senior colleagues was also present. The programme was attended by the large number of local farmers and an exhibition was also



arranged where the seeds of traditional and farmers varieties were displayed. Farmers were given training for the filing of the application and made aware about the provision of the PPV & FR Act, 2001 and Farmer's Rights therein. The Nukkad Natak and documentary on agro-diversity prepared by Authority were also screened and shown to the participants. During the meeting clarifications to the queries raised by different stakeholders including farmers were clarified.

- Visited onsite **Seed Saver Farmers Group in Jawahar block**, Dr. Manibhai Desai Nagar, Warje, BAIF Bhavan, Thane, Maharashtra along with Chairperson & Registrar-General of the Authority on 20 October, 2013. During the visit community gene bank maintained by the seed saver farmers and discuss with the farmers engaged in preservation and conservation of the Plant Genetic Resources.
- **Navsari Agriculture University (NAU), Navsari:** A one day Training-cum-Awareness programme was organised by KVK, Krishi Vigyan Kendra, NAU, Navsari on 21 October, 2013. Hon'ble Chairperson of the Authority, Vice-Chancellor, MPKV, Registrar-General and Dr. Ravi Prakash, Registrar, PPV&FR Authority also attended the programme. The programme was participated by the large number of local farmers and exhibition was also arranged where the seeds of farmers varieties was displayed. Farmers were trained for filling of the application and made aware about the provisions of the PPV & FR Act, 2001 and Farmers' Rights. The Nukkad Natak and Documentary on Bio-diversity were also screened and shown to the participants. Detail discussion on each and every point of application form for registration of farmers varieties were discussed.

- **Anand Agricultural University (AAU), Gujarat:** A one day training-cum-awareness programme was organised by Anand Agricultural University at their campus on 22 October, 2013. Hon'ble Chairperson of the Authority was the Chief Guest and was present with Dr. R.C. Agrawal, Registrar General. On this event the Vice-Chancellor of the University and other senior officers of the University were also present. The programme was attended by the large number of students of the University, research scholars, faculties and local farmers. During this training an exhibition of seeds of local and traditional varieties conserved by the farmers was also displayed.

### DUS Review Meeting

- A brainstorming session to review the DUS procedure and financial support mechanism was held under the Chairmanship of Prof. S. K. Datta, DDG (Crop Sciences), ICAR on 5 December, 2013 at NASC Complex, New Delhi. Apart from Prof. R. R. Hanchinal, Chairperson; Dr. R. C. Agrawal, Registrar General, Registrar(s) and other officers of the Authority, several other dignitaries, including Dr. Atanu Purakasyastha, Joint Secretary (Seeds), DAC; Dr. Indu Sharma, Project Director (Wheat); Dr. O. P. Yadav, Project Director (Maize), Dr. S. Rajendra Prasad, Project Director (Directorate of Seed Research); Dr. N. K. Dadlani, Director(NSAI); representatives from Seed Industry, Nodal officers (DUS) and several other scientists from ICAR Institutes / SAUs and officials from DAC participated. Shri Dipal Roy Choudhury, Joint Registrar, PPV&FRA made a brief overview on the preparatory phase (2001-08) and developments post 2008, physical and financial aspects of DUS centres, procedures adopted for DUS testing and





comparison of the DUS-VCU system. It was followed by a discussion and exchange of views on the manner of maintenance of DUS centres and DUS testing.

Dr. Swapan K. Datta, DDG (ICAR) & Chairman of the brainstorming session, opined that it is an established fact that the principles and procedures adopted for AICRP and DUS are fundamentally different. AICRP under ICAR created an infrastructure mainly to identify varieties for Value for Cultivation and Usage (VCU). It was decided that a Committee under the Chairmanship of Dr. R. K. Chawdhary, Former Project Co-ordinator (NSP) will further examine the issue of DUS testing and maintenance of centres by Co-opting Dr. O. P. Yadav, Project Director (Maize) and Dr. N.K. Dadlani from NSAI and recommend to the Authority.

● **19th Meeting of the Authority:** During



the 19th Meeting of the Authority held on 18 October, 2013 at NASC Complex, New Delhi, the proposal for expenditure for supporting the conservation and sustainable use of Plant Genetic Resources (PGR) for *in-situ* and *ex-situ* conservation for strengthening the capability of the Panchayats and local bodies in carrying out such conservation and sustainable use and for capacity building on *ex-situ* conservation in agro-biodiversity hotspots was discussed at length and it was decided

that a Committee may be constituted under the Chairmanship of Dr. B. S. Dhillon, Vice Chancellor, Punjab Agricultural University, Ludhiana for examining and submitting the recommendation in this regard.

Members unanimously emphasized for extensive training-cum-awareness programme about the PPVFR Act, 2001 especially at district / state level for the benefit of the farmers, breeders, seed industry, policy makers and other functionaries related to seed development. It was also decided by the Authority to have a brainstorming session for the review of existing DUS Testing policy and to submit the recommendations for the consideration of the Authority in its next meeting. During the said meeting, the Annual Accounts and Annual Report for the year 2012-13 of the Authority were approved and also adopted.

### Chairperson participation

Prof. R. R. Hanchinal, Chairperson, PPV&FRA,



New Delhi visited DMAPR, Anand on 22 October, 2013. Dr. R.C. Agrawal, Registrar General, PPVFRA also accompanied the Chairperson. He visited DUS experimental field and Medicinal Plants Botanical Garden at Lambhvel farm and also visited various Laboratories of DMAPR at Boriavi. He keenly observed the various distinct characters and lines identified in Kalmegh (*Andrographis*



paniculata Nees.) and expressed his satisfaction in the progress of work at the Centre and advised to submit the descriptors of the same at the earliest. He also visited the Botanical garden and field gene bank maintained at Directorate and showed his keen interest in the medicinal plant collections and appreciated the Directorate's effort in conserving the important wealth of the Country. A sapling of Karambola (*Averrhoa carambola* L.) was planted in the Botanical garden to commemorate his visit at DMAPR. Later, the Chairperson addressed the scientists and reminded about the great role of Indian medicinal plants and traditional systems of Medicines in keeping the health of millions of rural people. He opined that it is very important to find out the scientific base of therapeutic action of our major medicinal plants for getting the international attention. He congratulated the Director and his team for their effort in this direction.

### Foreign Visits

- **Seminar of UPOV in Sri Lanka: A seminar on 'Benefits of Plant Variety Protection Systems Inline with the UPOV Convention'** was jointly organized by Department of Agriculture (DOA), Sri Lanka, UPOV, Geneva, USPTO, USA & Ministry of Agriculture, Forestry & Fisheries (MAFF), Japan on 25-26 November, 2013 at Plant Genetic Resources Centre (PGRC),



Gannoruwa, Peradeniya, Sri Lanka. On the invitation of the UPOV a Indian delegation consisting by Dr. R.R. Hanchinal, Chairperson, PPV&FR Authority and Shri R.K. Trivedi, Deputy Commissioner (Quality Control), DAC and Dr. S. Maurya, ADG (IPR), ICAR and Dr. Sudhir Kochhar, National Coordinator, NAIP, ICAR attended the seminar and updated with regards to the implementation of PPV&FR Act in India.

### Foreign Visitors

- **Dr. Marie Haga, Executive Director, Global Crop Diversity Trust, Germany** along with her team members **Mr. Michael Fredrich Wilhelm Koch and Mr Luigi Maria Guarino** met Dr. R. R. Hanchinal, Chairperson at his office on 20 November, 2013. The discussions touched upon





various provisions of the PPV&FR Act, 2001, progress of the Authority in implementing the Act with special emphasis on farmers' varieties and its registration. Areas of mutual co-operation were also discussed and explored. Dr Prem Mathur, South Asia Coordinator, Bioversity International and Dr R C Agrawal, Registrar General, PPV&FRA were also present during the discussions.

- German Delegation visit to India from 2-6 December, 2013. A high level German delegation led by **Mr. Udo von Kröcher**, President, Federal Office of Plant Varieties (Bundessortenamt) visited PPV&FR Authority on 5 December, 2013 at NASC Complex, New Delhi. The delegation consisted of seven members including **Ms. Birgit Risch**, Head of Division South and Southeast Asia, Federal Ministry of Food, Agriculture and Consumer Protection; **Mr. Dieter Rücker**, Head of Division International Affairs, German Plant Breeders' Association (BDP) accompanied by **Ms. Sabine Raddatz**, Counsellor Food, Agriculture and Consumer Protection, Embassy of Germany, New Delhi. In the meeting the areas of mutual cooperation between the two countries in the field of Protection of Plant Varieties, Plant Breeders' Rights, DUS Testing and Capacity Building were discussed. Dr. Atanu Purkaystha, Joint Secretary (Seeds), Department of Agriculture & Cooperation reviewed the overall progress of bilateral co-operation between the two countries with all the stakeholders including representatives of NBPGR, NSC, SFCI, NSAI and PPV&FR Authority on 6 December, 2013 in Krishi Bhawan.

### Guwahati

The Principal Secretary, Govt. of Mizoram highlighted the importance of protection of plant varieties and their conservation. He also requested



the officers and the scientists for assisting the farmers and farming communities to file the applications for the crops / species for registration, which have been notified with the Authority. The President and General Secretary of All Mizoram Farmers Union (AMFU) Mr. Joseph H. Thanzuala and Mr. Zion Lalremruata also participated the training programme and handed over a set of 47 applications for registration of rice farmers' varieties.

In a special drive undertaken in the North-Eastern Region, the PPV&FR Authority made

concerted efforts for registration of the farmers' varieties for a week (12 – 16 November, 2013). During this period Dr. R.R. Hanchinal, Chairperson along with Dr. R.C. Agrawal, Registrar General, Dr. Ravi Prakash, Registrar and Dr. A.C. Sarma, Deputy Registrar were also present and several workshops were conducted in Manipur, Nagaland and one in Jorhat in Assam. The details of the Workshops/ Brainstorming Session / training-cum-awareness programmes are as under:-

- North-Eastern Hill Region Seed Meeting and training was held at the Conference Hall of ICAR, Manipur on 12 November, 2013. The forenoon session was chaired by Dr. S.V. Ngachan, Director, ICAR Research Complex for North Eastern Hill Region, Umiam, Meghalaya



and Dr. M. Datta, Joint Director, ICAR, Tripura as Co-Chairman. In the Morning session there were four presentations from Arunachal Pradesh, Mizoram, Nagaland and Sikkim Centre of ICAR.

- Dr. R.R. Hanchinal, Chairperson, PPV&FR Authority chaired in the afternoon session and Dr. S. Rajendra Prasad, Director of Seed Research, Mau as Co-Chairman of the session Meghalaya, Tripura and Manipur Centre of ICAR presented their presentations. There was also discussion on seed production for farmers'



varieties. The scientists of all seven ICAR NEH Research Stations attended the meeting.

- A **Brainstorming Session** on registration on Farmers' and extant varieties was organized by ICAR, Manipur on 13 November, 2013.



Dr. N. Prakash, Joint Director, ICAR Manipur welcomed the dignitaries. Chairperson, Registrar General and Registrar made their presentations on different areas with regards to



farmers' rights, benefit sharing and registration. Dr. S.V. Ngachan, Director, ICAR (NEH), Umiam and Dr S. Rajendra Prasad, Director of Seed Research, Mau encouraged the farmers for registration of their farmers' varieties for conservation as plant wealth of India. The awareness program witnessed participation of more than 200 persons including farmers and scientists from the region. All Manipur Trained Medicinal and Aromatic Plants Promoters Consortium (AMAPCON) handed over 157 rice farmers' varieties for registration to Dr. RR Hanchinal, Chairperson in the meeting. A farmers' fare was also organized where the farmers of Manipur displayed their valuable crop species and also the indigenous agro-products.

- **Training-cum-Awareness programme** was organized by KVK, Phek, Nagaland on 14 November, 2013 at CBCC Hall, Pfutsero, Nagaland. Dr. R.K. Singh, Programme



Coordinator, KVK, Phek welcomed the dignitaries. Chairperson, Registrar General and Registrar, Farmers' Rights addressed the audience. Dy. Registrar demonstrated the filling up of the application form for the registration. The training was also attended by Mr. Khazi-Lea, President, Phek Farmers' Association, Mr. Hewoto Sema DAO, Phek, Govt. of Nagaland KVK Phek scientists and



farmers. Local farmers of the area assured of their co-operation and submitted more than 80 applications to Guwahati branch office after getting endorsement of the District Agricultural Officer. The farmers displayed the unique collection of varieties for different crops cultivated by them.

- ICAR Research Complex for NEH Region, Nagaland Centre organized a training-cum-awareness programme on PPV&FR Act on **15 November, 2013**. Dr Bidyut C. Deka, Joint



Director, ICAR, Nagaland, Scientists of ICAR, Nagaland and KVK, Nagaland, Agriculture officers and farmers were present. More than 100 participants including farmers, scientists and students were present. About 60 applications for registration of farmers varieties of rice were

received. The Joint Director, ICAR, Nagaland assured of forwarding applications to branch office after completing the endorsement.

- **Training-cum-Awareness programme** was held at **Assam Agricultural University, Jorhat** on 16 November, 2013. More than 200 participants comprising of farmers, scientist,



professors and state agricultural officers were present. About 50 applications were received for registration. A field visit to the rice DUS test plot was also arranged at AAU, Jorhat. The Chairperson also availed the opportunity to visit the Rain Forest Research Institute (ICFRE), Jorhat to take stock of development of DUS test guidelines of bamboo, a project assigned by the Authority.





- **Second meeting of Task Force on developing DUS test guidelines of citrus** was held on 18 November, 2013 at Committee Room No. III NASC Complex, New Delhi under the



Chairmanship of Dr. V.A. Parthasarthy, and Dr. S.N. Pandey & Dr. Umesh Srivastava, former ADGs (Horticulture), ICAR, Dr. H. Ravishankar, Director, CISH, Lucknow and Dr. I.P. Singh, Principal Scientist and Principal Investigator (PI) of the Citrus Project from NRC on Citrus, Nagpur as members of the Task Force were also present. Dr. R.R. Hanchinal, Chairperson and Dr. R.C. Agrawal, Registrar General of the Authority also attended the meeting along with the officers of the Authority. Dr. I.P. Singh, PI made a detailed presentation on the DUS guidelines of acid lime and mandarin. The Task Force discussed detailed descriptors under the guidelines and extensive suggestions were made by members. Chairman of the Task Force requested the PI to include the various suggestions given in the meeting

and circulate the draft guidelines amongst the members within another one week time for their early finalization.

Dr. R. R. He congratulated to KVK, Kanker for receiving Zonal Award and urged that most of the farmers of the area must be registered with Authority for their local varieties through Krishi Vigyan Kendra, Kanker, to protect the prestigious plant wealth available in the form of traditional varieties of the area. About 125 farmers of the district, officers of State Department of Agriculture and scientists of KVK, Kanker were present.

A large number of farmers with their exhibits of agro diversity and farmers’ varieties were present. Dr. R.R. Hanchinal, Chairperson, Protection of Plant Varieties’ and Farmers’ Rights Authority (PPV&FRA), New Delhi was the Chief Guest and Dr. Ravi Prakash, Registrar, PPV&FR Authority was also present during these programme. Shri Umakant Dubey, Deputy Registrar, Ranchi also participated in these training-cum-awareness programmes. A large numbers of scientists, government officials, farmers including women & tribal farmers participated. Dr. R.R. Hanchinal, Chairperson, PPV&FR Authority in his opening remarks informed the objectives of the PPV&FR Act and made a presentation before the scientists and encouraged them for registration of farmers’ varieties of the state. farming communities eligible for such awards as constituted by the Authority. Dr. Bidyut C. Deka, Joint Director, ICAR Research Complex for NEH Region, Nagaland Centre, Jharipani in his welcome address stressed on the need for registration of the farmer' varieties and requested the house that North-Eastern Region was one of the important biodiversity hotspot areas in the world and that the opportunity should be availed to get the maximum benefit from the Authority.

Dr. R.C. Agarwal, Registrar General, PPV&FR Authority, New Delhi discussed the registration of farmers' varieties and shared information about the farmers' rights. Altogether 45 beneficiaries comprising of scientists and technical staffs from ICAR, Nagaland Centre, staffs and farmer representatives from KVK Dimapur; KVK Longlen; KVK Wokha, officials from district Agri. offices of Kohima, Mon, Kiphire, Mokokchung and Mon districts of Nagaland along with their farmer members and SARS, Yisemyong attended the programme.

### **Special Drive for registration of farmers' varieties in North-Eastern Hills**

To create awareness about the farmer rights as enshrined in the PPV&FR Act, 2001 among the stakeholders like farmers, researchers, plant breeders, scientists, students, NGOs, public /private



organizations. Authority is organising training-cum-awareness programmes and participating actively in Kisan Melas, Kisan Utsavs, Agricultural Fairs, International conferences on agriculture, National seminars and agricultural workshops.

Accordingly, Authority has provided Rs. 200.00 Lakh for conducting 250 training-cum-awareness programmes during the year 2013-14. So far more than 80 workshops have already been conducted and another 45 programmes are likely to be conducted by March, 2014. These training-cum-awareness programmes are being conducted through KVKs, State Agriculture Universities, ICAR Institutes and other Agricultural Development Agencies of the State Governments including NGOs especially in the agro-biodiversity hotspots areas in the states of Chhattisgarh, Jharkhand, Odisha, Rajasthan and Bundelkhand and North-Eastern Hill states.

### **Special Campaign for Registration of Farmers' Varieties**

Under the dynamic leadership of Prof. R. R. Hanchinal, Chairperson, Authority made a special drive for the registration of the farmers' varieties in the Bundelkhand, North-Eastern Region, Chhattisgarh, Jharkhand, which are agro-biodiversity hotspots of the country. So far, the Authority has received 923 rice varieties from different states as per details as under:
