Desired Experience: Experience in preparation of reports to be sent to various agencies, implement the official language/policies as per the instructions of the Government of India, translation work from English to Hindi and vice-versa etc. is essential. Responsibilities: Translation of the Annual Report, Financial Report, Web Content & Various Document of the Authority as and when available. Preparation and Submission of Quarterly, Half-Yearly & Annual Reports in the prescribed format. Assistance in the preparation of various official language inspections, such as the Parliamentary Committee, the Department of Official Language & the Ministry.	01	The remuneration will be paid as per DoE/DoPT, Govt. of India Norms

Tenure: The Consultant (Hindi) shall be initially engaged for a period of one year, which may be extended or curtailed subject to review at the sole discretion of the Competent Authority, PPVFRA.

Remuneration: The amount of remuneration so fixed will remain unchanged for the term of the contract. There will be no annual increment during the contract period nor any enhancement of the payment shall be done by the Authority. House Rent Allowance (HRA) will not be admissible and remuneration will

be governed on the basis of Department of Expenditure's Office Memorandum No. 3-25/2020-E.I)IA dated 09.12.2020, as detailed below:

Age Limit: The maximum age limit for applying for all categories of retired government employees should be 64 years as on the last date of application.

Travel Allowance: Travel Allowance (TA) will be payable as per Government of India rules.

Last Date: The last date for submission of application is within 30 days from the date of publication of the advertisement in the Employment Newspaper.

Leave: 1.5 days for each completed month of service, i.e. a maximum of 18 paid leaves in a calendar year. Unused leaves will neither be carried forward nor encashed.
