PUBLIC NOTICE (07 of 2024)

Under Section 3(3) of the PPVFR Act, 2001, the Central Government has designated the three Branch Offices of Plant Varieties Registry at Palampur, Pune and Shivamogga as Branch Offices of the Authority with the same territorial limits as notified in Official Gazette of India vide SO 182(E) dated 19.01.2017. The Central Government has designated the Branch Offices in accordance with the proposal of PPVFR Authority approved in its 38th Meeting held on 6th August, 2024.
